In April crews drilled on ladders and Ground Monitor Master Streams.

Along with hose testing crews will train on RIT skills, MAYDAY alerts & CPR downed Firefighters.

Vehicle, Equipment, and House Maintenance & Other:

- In April we had 1 new hire, FF/PM Timothy Tesch. Two members still on leave of absence (Naser, Corcoran) both firefighters.
- We are seeing some improvement in filling the schedule but we still have open shifts. We now have 32 members eligible monthly to fill the schedule.
- The Grant from the Illinois Department of Commerce and Economic Opportunity is moving forward. We have been awarded \$200,000.00 for the purchase of new SCBA. The check has arrived, all equipment has been ordered. I will let the Board know when all of the equipment arrives.
