Chief McMahon reported that there were 65 total calls for the month of March, 2022.

March 8th crews responded to 5967 W. 65th for a fire in Bedford Park. The fire went to a 2nd alarm. Crew did a nice job.

Training & Haz-Mat:

During March 7-11 crews utilized an acquired structure to complete hands-on training. This was a great opportunity for the department.

April 5th starts the In-House FAE class. 5 persons signed up for the class.

Vehicle, Equipment, and House Maintenance & Other:

- E905 went into FSI for repair. Vehicle was running rough and died out while on the way back from a call. FSI found a crack in the Fuel Filter Housing which was ordered from Detroit Diesel and replaced.
- We continue to be vigilant in the Pandemic and in February we had Zero members off duty for positive or suspected positive COVID-19. We continue to follow the CDC guidelines.
- In March we had one new hire: FF/EMT Daniel Golden; still have one member Herera on lay-up. Five members now on leave of absence: Brian Corcoran 1 year, Bob O'Loughlin 6 months, CJ Shefcik 3 months, Steven Dotson 3 months, Ryan Sheehan 4 months. Only 25 available for schedule.
- The Central Stickney FPD was awarded three grants in March and early April. The IPRF Safety Grant for \$1,989.00 was used to purchase 3 SEEK Thermal Imaging Cameras. The OSFM Small Equipment Grant for \$26,000.00 for 10 Fire Coats and Pants, and the FM Global Grant for Fire Preventions which is \$2,200.00 which will pay for Brian Bedtke's classes and now for Engr. Kevin Purvis.

Chief McMahon added that his goal and hope is that we use the inspector company for one year and then let Kevin Purvis and Brian Bedtke take over.

- 4. Natalie McBride (FSCI) was a little unclear as to what we (Central Stickney) wanted them to look at for the new racking going into 5800 W. 51st. Street. (03/08)
- 5. I received notification from FSCI that Central States Automatic Sprinklers called for inspection (03/04) at Hood Container Office Remodel 2nd floor 21 sprinklers working pressure hydro rough. (03/09)
- 6. I received notification from FSCI of Stickney Township Senior Center 4949 Long Ave. 1st submittal for a fire alarm. (03/10)
- 7. I received notification from FSCI Gaming Lounge Remodel 4829 S. Central Ave. 3rd submittal for a sprinkler system. (03/11)
- 8. I received notification from FSCI that Hood Container 4800 S. Austin Ave. fire suppression inspection on 03/14 passed with corrections. (03/15)
 - a. A final sprinkler system inspection will need to be completed.
 - b. The newly installed QR sprinklers shall be replaced with standard response sprinklers to match the existing standard response sprinklers which have not been replaced/modified.
 - c. The coverings protecting sprinklers from paint shall be removed prior to the final inspection.
 - d. The painted sprinklers shall be replaced.

- e. Surge clips shall be provided on the various hangers adjacent to the end branch line pendent sprinklers below the various suspended ceilings as system pressures exceed 100 psi.
- 9. I received notification from Natalie McBride (FSCI) Tron Solar called regarding the property at 4750 S. Lorel Ave. is being cancelled. (03/16)
- 10. Fred Hoegler (FSCI) was also a little unclear as to what we (Central Stickney) wanted them to look at for the new racking going into 5800 W. 51st Street. (03/16)
- 11. I received notification from FSCI that Hood Container 4800 S. Austin Ave. submitted fire alarm system modifications for the 2nd floor remodel were approved as noted. (03/18)
- 12. I talked to Sam Salazar (Epic-Restoration) regarding the sprinkler system that is needed to be installed at the property of 5034 S. Luna Ave. (03/24)
- 13. I received notification from FSCI of Stickney Township Senior Center 4949 Long Ave. 1st submittal for a fire alarm was approved as noted. (03/25)
- 14. I received notification from FSCI that Johnson Controls called for inspection (04/04) at Hood Container Office Remodel 2nd Floor alarm 23 devices. (03/29)
- 15. I received notification from FSCI that Central States Automatic Sprinklers called for inspection (04/04) at Hood Container Office Remodel 2nd Floor ASF 21 sprinklers Punch List & Final.
- 16. I still have not received the required information for 4837 S. Lotus Ave. I have once again sent a follow up email to Olivia Rodriguez. (03/28)
- 17. Tom Reinhardt (BFCCS) is still having trouble with the iPad; he will continue to complete the inspections via paper until the technical difficulty is completed. (03/28)
- 18. 3 inspections and 0 re-inspections completed by B & F Construction Code Services.
