# **CHIEF'S REPORT**

Mr. Frixen reported that there were 71 total calls for the month of May, 2022.

Loyola EMS Con-Ed was held on 5/11 & 5/13 for 3 hours each class.

In the month of May we focused our training on Firefighter Rescue and MAYDAY's. All went well.

All members that attended the in-house FAE class have been signed up to take the state exam in the upcoming months.

Vehicle, Equipment, and House Maintenance & Other:

- We continue to be vigilant in the Pandemic and in May we had Zero members off duty for positive or suspected positive COVID-19. We continue to follow the CDC guidelines.
- In May we had no new hires. We still have 1 member Herera on lay-up; Two members now on leave of absence: Brian Corcoran, Bob O'Loughlin. Paramedic CJ Shefcik who was on LOA resigned due to his full-time work schedule. Patrick McGivney and Duncan Lanzirotti both resigned because of their full-time work schedule and commitments to their full-time job does not leave them with any time for CS. Pat McGivney was recently promoted at his full-time job and his new responsibilities that take up his time. Duncann Lanzirotti was recently placed in charge of an explorer program at his full-time job and that does not allow him much extra time for CS. I wish them all the best. We are still struggling to fill the schedule and now have only 28 members eligible monthly to fill the schedule.
- We have had no new applications come in. It appears that our rate of pay is still the issue.
- In May the on-duty crews completed the annual Hose Testing. We lost 6 lengths of hose due to damage.
- A908 & A909 both passed Safety Lanes inspection in May.
- A909 went in for PM in May, during the PM Fire Services replaced the front brakes and repaired the air horn that was not working.
- E905 went in for service for "running rough". The problem was found and corrected. Fire Services replaced the Fuel Pick-up tube that was sucking air.

- 3. John Chwedyk of Burnham Nationwide, Inc. is the architect for the Target Sortation Center TI buildout at 5064 S. Merrimac Ave. They will be building out offices (fire alarm and sprinkler modifications required) and adding high pile rack storage in the warehouse. (05/12).
- 4. I received notification from FSCI that dnD Fire Protection called for inspection (05/24) at the residence 4804 S. Lorel Ave. 13DHR 19 sprinklers Final (05/20).
- 5. I received notification from FSCI that OSI Rose packaging 4900 S. Major Ave. submitted a 1<sup>st</sup> review for fire sprinkler modifications (05/20).
- 6. I received notification from FSCI that Target Sortation Center TI 506 S. Merrimac Ave, submitted a 1<sup>st</sup> review for a fire sprinkler modification. (05/24)
- 7. I received notification from FSCI that the residence 4804 S. Lorel Ave. fire suppression inspection on 05/24 passed no corrections required. (05/24).
- 8. 17 inspections and 1 re-inspection completed by B & F Construction Code Services.
